- Award of Restricted Stock Units (RSUs) with tax withholding rights granted under The Allstate Corporation Amended and Restated 2001 Equity Incentive Plan. Each RSU represents the right to receive, without the payment of any consideration, one share of Allstate common stock on the date(s) the restrictions lapse with respect to that RSU (the conversion date). Half of the RSUs represented in Column 9 will convert to common stock on January 2, 2009 and the remaining RSUs will convert to common stock on January 2, 2011.
