## Allstate Announces November 2019 Catastrophe Loss Estimate

NORTHBROOK, Ill., December 19, 2019 – The Allstate Corporation (NYSE: ALL) today announced estimated catastrophe losses for the month of November 2019 of \$33 million, pre-tax (\$26 million, after-tax). Catastrophe losses occurring in November comprised four events at an estimated cost of \$19 million, pre-tax (\$15 million, after-tax), plus unfavorable prior period reserve reestimates primarily from 2019 events.

Allstate previously announced \$237 million, pre-tax (\$187 million, after-tax), in estimated catastrophe losses for the month of October 2019, bringing estimated catastrophe losses for the months of October and November 2019 to \$270 million, pre-tax (\$213 million, after-tax).
